

Club Five Dock RSL – Golf Giveaway Promotion

The 'Golf Giveaway' will be conducted at Club Five Dock, 66 Great North Road, Five Dock NSW 2046, under the following Terms and Conditions and is open to members only.

Terms & Conditions

1. The 'Golf Giveaway' will commence on Tuesday 6 December 2011 and conclude on Monday 5 March 2012.
2. Entry Tickets are gained by Members in the following ways:
 - 2.1 Swiping their Financial Membership Cards through the Rewards Terminal at the participating local business partners which are advertised throughout the Club, whilst spending the minimum spend of \$10 per transaction one ticket will be rewarded, and one additional ticket for every \$10 spent thereafter in the one transaction.
 - 2.2 Swiping their Financial Membership Cards through the Point of Sale (till) at the 3 Peppers Bistro whilst spending the minimum spend of \$10 per transaction one ticket will be rewarded, and one additional ticket for every \$10 spent thereafter in the one transaction.
 - 2.3 Swiping their Financial Membership Cards through the Point of Sale (till) at the Club Bars whilst spending the minimum spend of \$3 per transaction one ticket will be rewarded, and one additional ticket for every \$3 spent thereafter in the one transaction.
 - 2.4 Members Swiping their Financial Membership Cards through the Rewards Terminal between the hours of 9am to 6pm, 8pm to 12am and 12.01am to 3am seven days a week
